ELIGIBILITY: Applicant must be a non-traditional female student from Erie, Huron, Ottawa or Sandusky Counties in Ohio returning to the classroom after some period of time in which her formal education was interrupted. The female student must be enrolled in a 2-4 year undergraduate degree program at a state or federal licensed college/university or vocational school. Minimum age is 23 years. The award will be paid directly to the school upon receipt of certification of enrollment from the school. No payment will be made directly to the student. To be considered for the award listed on this application, the applicant must meet the eligibility requirements. **APPLICATION MUST BE TYPED.** *NOTE: An incomplete, illegible or late application will prevent the applicant from consideration.*
